#### Community Engagement

At its ordinary Council meeting on the 26<sup>th</sup> of September 2018 the Shire of Mount Magnet resolved to prepare a draft Strategic Community Plan that will include advertising and preparing a community survey form for the purpose of accepting comments and written submissions to the draft Strategic Community Plan from the community. This will also coincide with undertaking a community engagement and consultation process as follows;

- November 2018 - Mount Magnet Emergency Service(s) groups and organizations
- November 2018 - Badimia Land Aboriginal Corporation
- December 2018 - Annual Meeting of Electors
- December 2018 – Mount Magnet Business groups
- February 2019 – 2<sup>nd</sup> Community Workshop with community BBQ at the Recreation Centre
- February 2019 – Presentation of submissions and feedback to Council February 2019 Ordinary Meeting for consideration.

#### ***What is Community Engagement?***

Community Engagement involves a variety of activities with the purpose of involving community members in the development of Council's Strategic Community Plan and other strategy plans relevant to the delivery and operation of Council. It is a process that provides an opportunity for the community to be involved in the decision-making process and contributes valuable information on identified key priority areas that is about encouraging involvement, participation and communication between Council and its community members.

The Community Engagement Survey Form is an important part of this process and the following questions relating to the current Strategic Community Plan (the Plan) is intended to request a brief reply from the community regarding the key areas in the current Plan that will inform Councils decision when reviewing the Plan. Community members are also encouraged to submit more detailed written submissions to the Plan to Council at the address below.
